

**FIRST AMENDMENT TO THE  
CREEKMONT COMMUNITY ASSOCIATION, INC.  
ARCHITECTURAL CONTROL GUIDELINES

As certified below by an officer of the Creekmont Community Association, Inc. ("Association"), a majority of the Members of the Association's Modifications Committee ("MC") and the Board of Directors have voted for, adopted, approved and consented to the following amendment to the Association's Architectural Control Guidelines for the MC ("Guidelines"). The Guidelines were recorded on August 28, 2006, under Fort Bend County Clerk's File Number 2006106283.

1. Article 3.0, Paragraph 3.7 is deleted in its entirety and replaced with the following:

3.7 Portable goals must be commercially manufactured. Portable basketball goals are prohibited from being placed, even on a temporary basis, at a location (e.g., driveway, street) where play will take place in a street. When not in use, a portable basketball goal must be stored on a portion of the Lot not visible from the street.

2. Article 13.0, Paragraph 13.2 is deleted in its entirety and replaced with the following:

13.2 The installation of metal grids, burglar bars or storm shutters on the exterior of any window or door that is visible from the street or the Common Properties is prohibited. Any metal grids or burglar bars must be installed in the interior of a home and be screened at all times by shades, shutters, curtains, blinds or other suitable covering material, and must be submitted to the Committee for approval.

Except for this amendment, the Guidelines are otherwise unaffected and remain in full force and effect.

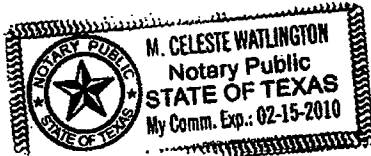
