- (e) Updated Resale Certificate more than thirty (30) days but less than one-hundred eighty (180) days after original request - \$75.00
(thereafter any additional requests must be for a new Resale Certificate for the full amount listed in (a));
- (f) Capitalization Fee - \$300.00;

(9) Prospective purchasers are advised to independently examine all dedicatory instruments and governing documents for the Subdivision and Association, as well as performing a physical inspection of the property and common areas, prior to purchase. 
