## **How & Where to Vote**

For this year's Annual Meeting, the Association will be using electronic voting through a third- party representative called Vote HOA Now. Electronic voting is a safe and efficient method to increase participation while saving both time and money for the Association.

Each property with a registered email on file with [www.crest-management.com](http://www.crest-management.com) will receive an email invitation by Monday, May 18, 2026, to vote from the community voting site. If you do not receive an email by Tuesday, May 19, 2026, please contact Assistant Manager Nallely at [Nallelya@crest-management.com](mailto:Nallelya@crest-management.com) for assistance.

Please remember that only one vote per property is allowed, so the online ballot will only be sent to one person per household. If you did not receive the email ballot, please check with your significant other and check your junk mail BEFORE reaching out to Nallely for your registration code.

Voting online is easy and quick! You will have three steps!

1. Receive the email and click the link to go to the voting site
2. Register for the vote by entering your name, email, and creating a password
3. Make your choices on the ballot and submit

When your vote is complete, you will receive both an on-screen confirmation and an email confirmation that the vote has been recorded. The entire process takes only a few minutes - less time than it did to read these instructions!
