QUIT-CLAIM DEED

Know All Men By These Presents:

That Thornwood Club, Inc., a Texas corporation acting by and through its duly authorized officers, hereinafter called Grantor, of the County of Harris and State of Texas for and in consideration of the sum of Ten and no/100 Dollars, and other valuable consideration to it in hand paid by Thornwood Fund, Inc., a Texas corporation, hereinafter called Grantee, of the County of Harris and State of Texas, the receipt of which is hereby acknowledged, does by these presents Bargain, Sell, Release, and Forever Quit Claim unto the said Thornwood Fund, Inc., its successors and assigns all its rights, title and interest in and to those certain parcels of land lying in the County of Harris, State of Texas, described as follows to-wit:

Parcel 1: Consisting of three tracts, as follows:

TRACT 1

A tract or parcel of land out of Reserve "A" of THORNWOOD SUBDIVISION, SECTION TWO (2), a subdivision in Harris County, Texas, according to the map thereof recorded in Volume 143, Page 1, of the Map Records of Harris County, Texas, said tract or parcel of land containing 0.526 acres, more or less, and being described by metes and bounds as follows:

BEGINNING for the Southwest corner of the herein described tract, at the common corner of Lot 12, Block 1, and the Reserve "A" on the North right of way line of Turkey Creek Drive, based on a width of 60 feet, of the said Thornwood Subdivision, Section 2;

THENCE North 0 deg. 07 min. 56 sec. East along the common line of said Lot 12 in Block 1 and Reserve "A" a distance of 92.02 feet to a point for the Northwest corner of the herein described tract;

THENCE North 89 deg. 05 min. 44 sec. East, a distance of 79.93 feet to the point of curvature of a 178 foot radius circular curve to the left;

THENCE easterly along the said 178 foot radius curve having a central angle of 43 deg. 12 min. 02 sec. through an arc length of 134.21 feet to a point in the Southwest right of way line of Memorial Drive, based on a width of 100 feet, for the northerly Northeast corner of the herein described tract;

THENCE South 44 deg. 06 min. 18 sec. East along the said southwest right of way line of Memorial Drive a distance of 82 feet to a point for corner;

THENCE South 1 deg. 25 min. 24 sec. West, a distance of 14.01 feet to a point for corner of the herein described tract, said corner being on the northerly right of way line of Turkey Creek Drive, based on a width of 60 feet and as shown on said recorded map of Thornwood Subdivision, Section 2;

THENCE westerly along the said northerly right of way line of Turkey Creek Drive, being a curved line, with a radius of 270 feet, through an arc length of 193.58 feet and a central angle of 41 deg. 04 min. 42 sec. to a point of tangency with a line bearing South 89 deg. 05 min. 44 sec. West;

BEGINNING for a corner of the herein described tract at the N.E. corner of Lot 12, Block 1, and the west line of Reserve "A";

THENCE N. 0° 02' 53" W. 21.41 feet for the N.W. corner;

THENCE S. 57° 26' 11" E. 59.20 feet to a point for the N.E. corner;

THENCE S. 0° 07' 56" E. 11.75 feet to a point in the north line of a 0.526 acre tract for the S.E. corner;

THENCE S. 89° 05' 44" W. along the north line of a 0.526 acre tract, 50.00 feet to a point in the east line of Lot 12, Block 1 for the S.W. corner;

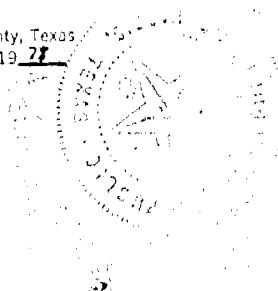
