RECITALS:

AMENDMENT:

The Board of Directors hereby amends the Bylaws of the Association as follows:

Article II, Section Nine, of the Bylaws is hereby amended to read as follows:

<u>Section Nine. Quorum</u>, The Members (present in person or by proxy) holding five percent (5%) of the total number of votes in the Association shall constitute a quorum at any meeting of Members. Once a quorum is established, the meeting shall be validly called and held and the quorum may not be defeated by the subsequent departure of a Member. If a quorum is not present at any meeting of Members, a majority of the Members present may adjourn and reconvene the meeting from time to time without further notice, until a quorum shall be present or represented. At such reconvened meetings, at which a quorum shall be present or represented by proxy, any business may be transacted as was set out in the notification of the original meeting.
