

EXHIBIT "A" TO TWIN LAKES HOMEOWNERS ASSOCIATION, INC. CERTIFICATE: POLICY FOR USE OF POOL FACILITIES BY NON-MEMBERS

TWIN LAKES HOMEOWNERS ASSOCIATION, INC.

POLICY FOR USE OF POOL FACILITIES BY NON-MEMBERS

WHEREAS, Twin Lakes Homeowners Association, Inc. (the "<u>Association</u>") hereby adopts a policy for use of the Association's pool facilities by persons who are not residents of the Twin Lakes subdivision ("<u>Non-Members</u>"), as such terms are defined in the Association's Declaration of Covenants, Conditions and Restrictions;

The following policy shall govern use of the Association's pool facilities located 13200 Twin Lakes Blvd, Houston, TX (the "Pool Facilities") by Non-Members. The Association's Board of Directors may modify this policy at any time or from time to time.

- Non-Members may utilize the Pool Facilities for a single swim season upon (a) payment of the
 applicable fee for either an Individual Membership or a Family Membership, and (b) execution of a
 User Agreement (as defined below). An Individual Membership shall apply to only one adult person.
 A Family Membership shall apply to only the parents and minor children of a single family.
 Individual Memberships shall not be permitted to invite guests. Family Memberships shall be
 permitted to invite guests on the same basis as residents.
- 2. The initial fee for an Individual Membership shall be \$500.00 per swim season and the initial fee for a Family Membership shall be \$1,250.00 per season. Such fees (a) are not refundable, (b) may be modified by the Association's Board of Directors at any time or from time to time, and (c) shall not be pro-rated for partial swim seasons.
- Each Individual or Family Membership will include one season pass identification entry card; any additional cards must be purchased at the rate then in effect.
- 4. Non-Members must execute a Pool Facilities User Agreement (as now existing or hereafter amended, the "<u>User Agreement</u>").
- 5. An Individual Membership or Family Membership shall apply to only one swim season. Non-Members wishing to use the Pool Facilities for another season must (a) pay the applicable fee for that season, and (b) execute another User Agreement.
- 6. The Pool Facilities are provided by the Association on an "AS-IS" basis. Non-Members agree to assume all risk of injury, loss or damage to themselves and their family members and permitted guests (collectively, "Non-Member Persons"), or any goods, materials or property, arising out of or in connection with use of the Pool Facilities.
- 7. In consideration of being granted access to the Pool Facilities, (a) Non-Members agree to be financially responsible for any and all damage to the Pool Facilities caused by any related Non-Member Person, and (b) Non-Members release and discharge the Association and its directors, officers, committee members and other volunteers, pool management company, property management company and other agents (the "Association Persons") from and against any claims, suits, costs, losses, damages, liabilities or expenses (including, without limitation, attorneys' fees) arising out of or in connection with use of the Pool Facilities by any of the Non-Member Persons, whether or not caused or contributed to by any act or omission (negligent or otherwise) of any of the Association Persons. In that regard, Non-Members agree to defend and indemnify the Association against any and all claims asserted by any resident or other Non-Member or Non-Member or Non-Member.

Member Person arising in whole or in part from the activity of Non-Members' use of the pool facilities, as provided for herein.

8. The Association reserves the right to terminate any Individual Membership or Family Membership, without refund of any portion of the applicable fee, due to any breach or violation of this Policy, the User Agreement or the pool rules by any Non-Member Person.

POOL FACILITIES USER AGREEMENT

- By accepting this Agreement, the Association agrees to allow the Non-Member Persons (as defined in the Policy) to use the Pool Facilities for a single pool season, subject to the terms and conditions set forth in this Agreement and the Policy.
